

## Owner checklist – England and Scotland

Animal and Plant Health Agency (APHA) staff/Official Veterinarian (OV)/Approved Tuberculin Testers (ATTs) pass to the owner after disclosure of the reactors.

At your latest TB test reactors have been disclosed. Your premises is now under automatic restrictions, meaning that you are prohibited from moving bovine animals both onto and off the premises except under licence.

| 1.  | Reactor animals must be properly isolated. | 3.  | Reactors must have passports available at the time of the valuation. | 4.  | Pedigree animals must have full certificates available at the time of the valuation. If this documentation is not available, the animal will be valued as commercial stock. | 5.  | Movement records must be made available (if valuation carried out on farm). It may be necessary for the visiting officer to take records or a copy if you have one available. | 9.  | Reactors going into the abattoir must be clean when presented to the haulier. The Food Standards Agency (FSA)/Food Standards Scotland (FSS) have an information leaflet 'Clean Beef Cattle for Slaughter: A guide for producers' which is available at <a href="http://www.food.gov.uk">www.food.gov.uk</a> . This defines the criteria for 'too dirty' to be processed. 'Compensation will be reduced by 50% for any animal that cannot be processed in the abattoir because it is too dirty. | <input type="checkbox"/> |
| 10. | After the reactors have been removed, cleansing and disinfecting of the area occupied and any equipment used must take place using an approved disinfectant. | 13. | If you are not the owner of the reactor, please inform APHA when they contact you.
